# Port and camping regulations

December 2023

These regulations apply to all sites and facilities of the Jachthaven and Camping De Domp Foundation. The basic principle is that we jointly ensure safety and prevent nuisance.

## <u>General rules</u>

- Anyone on the grounds must follow the instructions of the harbor master, as well as the rules of these regulations.
- Advertising for any purpose is not permitted in the ports and on the grounds of De Domp without written permission from the board. The same applies to peddling or otherwise offering items for sale.
- In our parking lots, parking is only allowed within the designated spaces. The areas must always be kept accessible to emergency services. Outside the parking areas, parking is only permitted at an assigned camping pitch or with permission from the harbor master.
- In the interest of safety, you should drive at walking pace on the sites.
- Electric cars may only be charged at designated charging stations and not at regular 230 volt connections on the sites.
- Dogs are allowed on the grounds, provided they are kept on a leash. Excrement must be cleaned up immediately by the person walking the dog.
- The use of barbecues and cooking appliances is permitted, except on the scaffolding, provided they are placed safely and sufficiently off the ground. No danger, damage or nuisance may arise. Other forms of open fire and fireworks are not permitted.
- The drinking water taps on the sites are only for taking drinking water and are not used for cleaning cars, ships or camping equipment, for example.
- Cycling on the jetties is not permitted.
- Between 10 p.m. and 8 a.m., noise on the sites must be kept to a minimum and any form of nuisance must be prevented.
- The sanitary facilities must be kept tidy and the site tidy.
- Waste must be separated into components as indicated on the waste containers. Only normal household and recreational waste may be deposited in these containers.
- Excessive use of alcohol must be prevented and the possession or use of drugs and/or laughing gas is not permitted.
- Aggression, the threat and use of violence, discriminatory comments, sexual intimidation and public urination will not be tolerated and may lead to immediate removal of the person concerned.
- Passers-by or campers arriving after 6 p.m. can consult the information at the reception entrance.



- Damage caused to property of the Foundation or third parties must be reported immediately to the harbor master. This also applies to situations from which damage could arise.
- Persons under the age of 18 may only spend the night on our sites or on board ships if they are directly accompanied by someone who is 18 years or older.
- The rates for the use of our sites and/or harbors by passers-by or camping guests are listed on the website www.dedomp.nl

#### Additional rules for the ports

- Berths are assigned by the harbor master.
- Toilets discharging into open water may not be used and bilge water may not be pumped overboard into surface water.
- Batteries for the electric propulsion of a ship may only be charged after prior consultation with the harbor master and under the conditions he/she sets. This rule does not apply if a power connection via AanUit.net is used
- In the ports it is mandatory to sail slowly. On arrival and departure, you must sail to and from the berth along the shortest route. Running engines and ship propellers should be limited as much as possible.
- Swimming and playing with boats and dinghies in the harbors is not permitted to prevent unsafe situations.
- The allocated passer-by berth can be used until 12:00 noon. Extending the stay must be agreed with the harbor master before 11:00 am.

## Additional rules for the campsite

- Camping and camper pitches are allocated by the harbor master.
- 1 car may be parked at the assigned location/accommodation, unless the harbor master announces that parking is not permitted. Parking is not allowed on the tent field.
- Batteries for the electric propulsion of a camping equipment may only be charged after prior consultation with the harbor master and under the conditions he/she sets.
  - You can check in for a place at the campsite from 1 p.m.; on the day of departure you can use the assigned place until 11:00 am. After 11 a.m. on the day of departure, the car or camping equipment can, if necessary, be parked in the municipal parking lot outside the port and camping grounds.

#### Closing remarks

- The Rental Regulations also apply to permanent berth holders of the Jachthaven and Camping De Domp Foundation.
- Additional rules may apply for certain periods (e.g. Sneek Week).
- In situations not provided for in these regulations, the harbor master will decide.
- The harbor master is authorized to remove guests from the harbor or from the campsite without refunding mooring or camping fees. The harbor master applies this authority if these regulations are not complied with, there is nuisance and the person concerned has first been warned.



- The Foundation is not liable for damage of any nature or caused by any cause to persons or goods or for loss or theft of any property.
